

IIFL Fund, the Controller is an umbrella investment company with variable capital (société d'investissement à capital variable). In the course of its business and while dealing with Investors, investors and website users may become privy to your personal information including information that is confidential in nature.

For purpose of this Privacy Policy, wherever the context so requires the term "You" or "User" shall mean any natural or legal person including Online and offline investors and the term "We", "Us", "Our" shall mean IIFL Fund.

We at IIFL Fund respect the privacy of everyone who visits this website and are committed to maintaining the privacy and security of the personal information of all visitors to this Website.

We view protection of your privacy as a very important principle. We understand clearly that You and Your Personal Information is one of our most important assets. We store and process Your Information including any sensitive financial information collected, if any, on computers that may be protected by physical as well as reasonable technological security measures and procedures. If You object to Your Information being transferred or used in this way, please do not provide the details of your information on the Website.

We keep ourselves abreast with the global trend and have updated this policy to capture requirement under GDPR (General Data Protection Regulation) as applicable to EU Customers.

The Controller may share/transfer / license / convey some or all of your personal information with another business entity to carry out any business activity or re-organization, amalgamation, restructuring of business or for any other reason whatsoever. Once you provide your information to us, we may use such information to provide you various services with respect to your transaction conducted with IIFL Fund and IIFL Group (IIFL Group collectively refers to IIFL Wealth Management Limited and its subsidiaries across the globe).

Our policy on the collection and use of personal information and other information is outlined below.

## **Collection Of Sensitive Personal Data Or Personal Information:**

The Controller may for purpose of rendering its services, collect personal information such as:

- Name, gender, residential / correspondence address, telephone number, date of birth, marital status, email address or other contact information;
- Identification Documents, KYC Status, Signature and Photograph;
- Bank account or other payment instrument details;
- any other detail for providing services

The Controller will continuously endeavour to ensure that Personal Data shall be used in line with all applicable data protection laws including GDPR. Your information will be kept secured with restricted access according to the 'need to know' principles.

The Controller or its authorized agents shall not retain or store that information for longer than is required for the purposes except when the information may lawfully be used or is otherwise required under any other law for the time being in force.

The information collected shall be used for the purpose for which it has been collected.

By agreeing to avail the service offered by the Controller you have agreed to the collection and use of your Sensitive Personal Data or Personal Information by the Controller.

## **Right to Opt out:**

You always have the right to refuse or withdraw your consent to share/dissemination of your Sensitive Personal Data or Personal Information by contacting the customer care. However, in such an event, you would no longer avail the services of the Controller which require data sharing. The opt out request would not be applicable to the correspondence and communications already initiated by the Controller.

## **Communications:**
